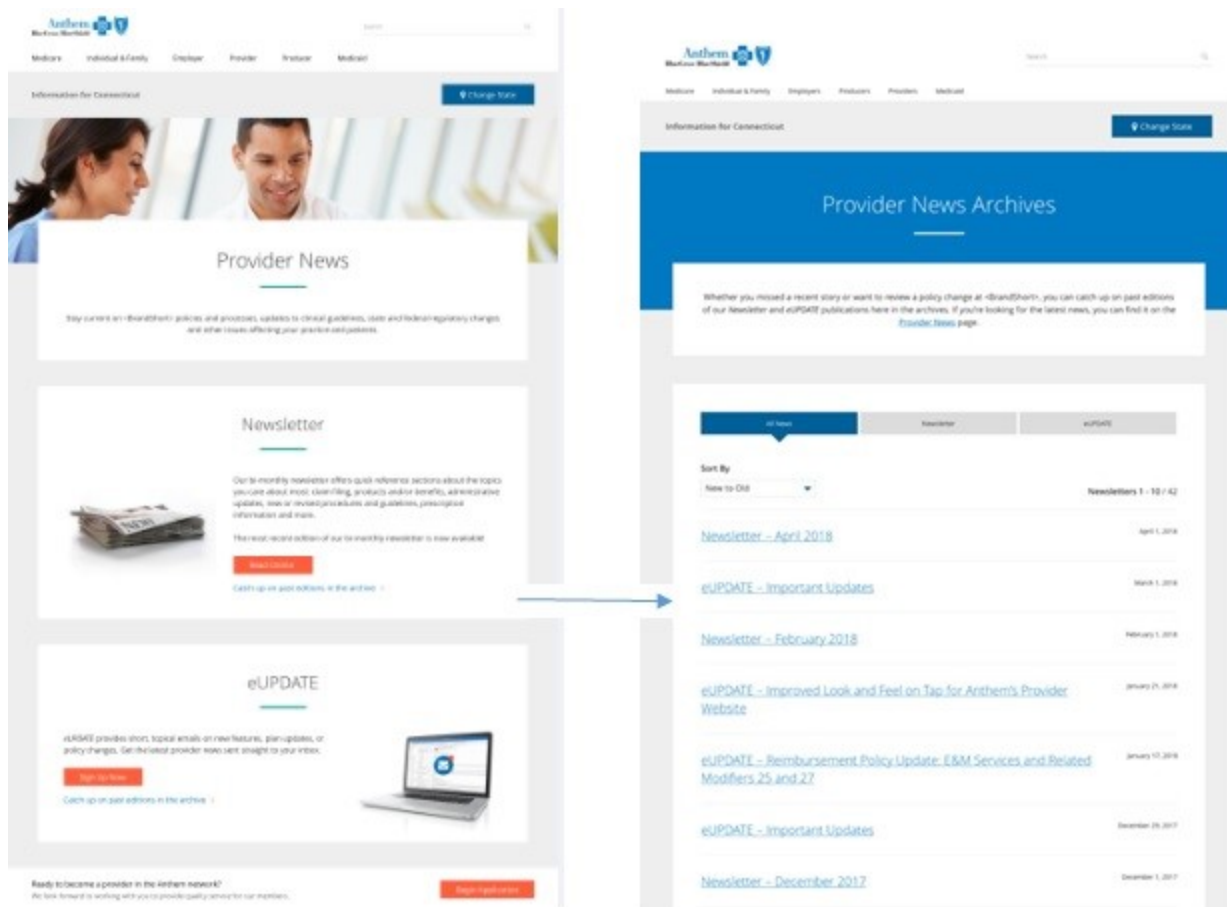


Anthem launches additional changes to anthem.com in October
